



I was appointed to serve on Richland County's Judicial Center Committee and was elected chairman by members of this committee to help find solutions to renovate or replace our county's central courthouse.

Over the next year, this committee will continue to work to create a plan that either renovates or replaces our county's judicial center.



Historic airplane hangar gets new life, to open this Summer

Approved by County Council to restore and preserve the historic Curtiss-Wright Hangar at the county's Owens-Hamilton Airport, developers will open a brewery and dining destination this summer in the Rosewood neighborhood.

Once used by Amelia Earhart and one of only 8 hangars on the National Register of Historic Places, this project is a welcome addition to our community that breathes new life into a building once on the verge of being lost forever.


Improving accountability in Richland County's Hospitality Tax program
